

## Schedule of Fees as of 2026

The Schedule of Fees is provided to parents in accordance with, and should be read in conjunction with, the School's Enrolment Terms and Conditions.

## **Acceptance Fee**

- 1.1. This fee is a one-time acceptance of enrolment fee payment payable per student within fourteen (14) days of the date of the letter of offer of enrolment is issued by the School.

## **2. Fee Discounts**

- 2.1. Advanced Payment Discount:

Where the Tuition Fee is paid in full by the due date as stated in the Schedule of Fees, a discount of \$170.00 will be applied in reduction of the prescribed amount.

- 2.2. NEW Sibling Payment Discount:

2<sup>nd</sup> child's fees – 10% discount

3<sup>rd</sup> child's fees – 15% discount

Any subsequent children's fees – 20% discount

- 2.3. Where the Advance Payment Discount and Sibling Discount are both applicable, the Sibling Discount will be applied to the Tuition Fee before the application of the Advanced Payment Discount.
- 2.4. A Fee Discount will only apply where the Fee is paid by the relevant due date. Any payments made after the due date will result in the discount being forfeited.

## **3. Annual Building Levy**

- 3.1. The Annual Building Levy Fee is a fee payable annually by the child's family each year of enrolment and not payable per the number of children enrolled at the School.
- 3.2. Future development of the School will be assisted by contributions to the Building Levy. Building alterations, minor building projects and eventually moving to new premises will be made possible by Building Levy donations, as Tuition Fees are not set to cover this. At this stage, families are only required to contribute the amount shown in the above Schedule of Fees, however they are encouraged to contribute more than the suggested amounts when their circumstances allow them to do so.

## **4. Refund Policy**

- 4.1. Payments made to the School are not refundable.

## **5. Tax Deductable Donations**

5.1. Tax deductible donations can be made to The School Building Fund. These funds will help us pay for new facilities, upgrades to existing facilities & the acquisition of much needed land.

## **6. Enrolments After Commencement of a Term**

6.1. When a student commences at the School more than two weeks after the Term has commenced, the School Term Tuition Fee will be charged on a pro rata basis.

## **7. Accounts**

7.1. Accounts for fees are invoiced to the Parent annually or quarterly and must be paid at the times specified in the accounts and in accordance with the Schedule of Fees. The Acceptance Fee will be invoiced independently of all other fees.

7.2. One Full Terms Notice must be given in writing to withdraw a student from the School. The applicable School Term Tuition Fee will be charged in lieu of this notice. The Parent will also be required to pay all other outstanding fees.

## **8. Goods and Services Tax (GST)**

8.1. Under current law, GST is not payable on fees relating to tuition.

8.2. If applicable, the School reserves the right to apply GST in accordance with legislation current at the time.
